

# TI'CAMPING DES BOTTRAIS

## RULES OF PROCEDURE

The Ti'Camping des Bottrais is a Campsite Declared in the Town Hall of Foulenay.

The manager is the SARL LES BOTTRAIS, represented by Mr and Mrs MEURANT, 2 rue de l'Etang Belain, 39230 FOULENAY.

The Ti'Camping des Bottrais has a maximum of 6 pitches and can not accommodate more than 20 people at the same time. It is open from April to October, for a period of 6 months, the opening and closing dates vary according to the weather.

It is open to any person wishing to stay in a quiet corner of nature.

No noisy activities are organized or allowed; fishing is allowed to campers, provided that they respect the fishing rules and have paid for their pitch.

### GENERAL CONDITIONS

#### 1. Conditions of admission and stay.

To be admitted entering, settle or stay on the campsite, it is necessary to have been authorized by Mr. or Mrs. Meurant or their representative after payment of the fees. The fact of staying on the campsite implies acceptance of the provisions of these rules and the commitment to comply with them. No one can may take up residence on the campsite. Any infringement may lead to the expulsion of its author with recourse to the police if necessary.

#### 2. Formalities

Minors who are not accompanied by their parents will only be admitted with the written authorization of their parents. Any stay at least one night in the campsite must first present their identity papers to the person in charge and complete the formalities required by the police.

#### 3. Installation

The outdoor accommodation and related equipment must be installed in accordance with the instructions given by the manager or his representative. The sites are "bare" and free, provided that they do not interfere with the campers already set up. The tenants of the Tente Libellule will have a specific contract.

#### 4. Reception desk

It is located at the reception of Gîtes les Bottrais, 2 rue de l'Etang Belain, 39230 FOULENAY. You can contact Sophie MEURANT at 06 48 04 18 58. The office or the telephone reception are open from 8:00 am to 8:30 pm.

The fees are paid at the reception desk upon arrival. Their amount is fixed according to the posted tariff. They are due according to the number of nights spent on the site.

The rentals of the Libellule tent are subject to a specific contract and will be paid in advance, with a deposit and balance.

#### 5. Display

The present rules and regulations, as well as the rates, are posted at the entrance of the campground and at the reception desk. It is given to each customer who asks for it.

#### 6. Departure procedures

Customers are invited to inform the reception office of their departure the day before. Clients who intend to leave before the opening time of the reception desk must pay the balance of their stay the day before.

## 7. Noise and silence

Guests are asked to avoid any noise or discussion that might disturb their neighbors. There must be complete silence from 10:00 pm to 7:00 am. Noise-making devices are prohibited. The closing of doors and trunks must be as discreet as possible.

## 8. Animals

Dogs and other animals must never be allowed to run at large. In the absence of their owners, they must not be left alone on the campground, even if they are locked up. **Dogs poop must be picked up by their owner.** Animals are not allowed in the showers. They are not allowed for visitors.

## 9. Visitors

Visitors may be admitted to the campsite under the responsibility of the campers who receive them. They must declare their number and identity at the reception desk. **They are not allowed to go fishing.**

## 10. Traffic and parking of vehicles

Inside the campground, all vehicles are not allowed to circulate around the pond. Anglers and visitors must leave their vehicle in the carpark, cyclists must get off their bike.

## 11. Conduct and appearance of the facilities.

Everyone is required to refrain from any action that could harm the cleanliness, hygiene and appearance of the campsite and its facilities, especially the sanitary facilities.

**It is forbidden to touch the solar and gas installations and to climb on the solar panels.**

It is forbidden to throw wastewater on the ground or in the gutters. The customers must empty them in the facilities provided for this purpose. Household garbage and waste of any kind must be deposited in the bins at the entrance of the campsite. Washing is strictly forbidden outside the bin provided for this purpose.

Common dryer to hang up the laundry.

Plantations and floral decorations must be respected. It is not permitted to mark the location of a facility by personal means, nor to dig the ground. The site that has been used during the stay must be returned clean and in good condition.

## 12. Sanitation.

The sanitary pole is totally autonomous and works with solar energy; please use electricity reasonably so as not to totally discharge the batteries and find yourself in the dark; also think of the other users.

The campsite is equipped with an autonomous sanitation system with septic tank. For this reason, but also for ecological reasons, **we ask all our clients to use the organic cleaning products** provided and put at your disposal. **All areas must be left clean.**

## 13. Degradations.

Any damage will be billed to the client and will be charged to the client. It is expressly reminded that **children are under the responsibility of their parents.**

## 14. Security

a) Fire. Ground fires are strictly prohibited. Barbecues and stoves must be kept in good working order and not be used in dangerous conditions. Beware of wind and dry grass.

In case of fire, notify the management immediately. A fire extinguisher is available in the sanitary area in case of emergency.

b) Cigarettes. Smoking is strictly forbidden in the sanitary facilities and in the rented accommodation. Smokers are invited to be very vigilant. It is strictly forbidden to drop cigarette butts on the ground, the use of an ashtray is compulsory.

c) Theft: The management declines all responsibility in case of theft or damage on the campsite. The camper is responsible for his own installation and must inform the manager of the presence of any suspicious persons.

#### 15. Games

Children must always be under the supervision of their parents. No violent or disturbing games may be organized. The playground is provided under the responsibility of the parents. Please note the presence of deep ditches.

#### 16. Pond CAUTION:

Swimming and use of the boat is forbidden. Do not throw anything in the water. We remind parents that it is formally forbidden for their minor children, or under their responsibility, to play alone near the pond. Children must be always under immediate supervision. In case of accident, the campsite will not be responsible. For obvious safety reasons, underage children must not under any circumstances be left alone on the campsite or in the accommodations.

#### 17. Rental insurance

The client must check with his insurance company that he has a holiday extension as part of his home insurance contract and its conditions of guarantee. If this is not the case, the tenant is required to insure himself against the risks inherent to his occupation. Namely: theft, loss, damage of personal effects. He must also insure himself for the degradations which he could cause in the lodging given in hiring or in the campsite, caused by him or his companions. Clients must provide proof of their insurance upon arrival.

#### 18. Infringement of the internal regulations

In the event that a resident disturbs the stay of the other users or does not respect the provisions of these rules, the campsite manager is responsible for the good order and good behavior of the camp. He has the duty to sanction serious breaches of the rules and if necessary, to expel their authors. The disrespectful behavior, even aggressive towards the manager or customers, will lead to expulsion without notice. In case of criminal offence, the manager can call the police.

In case of difficulties arising for the execution of the present rules for any reason whatsoever, and if no amicable solution can put an end to the dispute, the courts will have exclusive jurisdiction.
